Mansfield Junior Badminton Club

Title

The name of the club shall be '**Mansfield Junior Badminton Club**' (MJBC)

Aims and Objectives

MJBC shall encourage the development of badminton for juniors from the community and in doing so its activities include:

- ◆ Providing facilities for playing the sport of badminton for its members
- ◆ Providing regular coaching for its members
- ◆ Providing opportunity for competitive play and competitions
- ◆ Affiliating to Badminton Association of England and Nottinghamshire Junior Badminton Association and to liaise with them.
- ◆ Liaise with other organisations with mutual interest
- ◆ Publicise the Club's activities and achievements
- ◆ Encourage parents to engage in the MJBC's activities

Membership

The playing members of MJBC shall be open to juniors under the age of 17 years on the 1st January preceding the date of joining. Minimum age is 7 years old.

The committee shall reserve the right to:

- ◆ Limit the number of members at MJBC
- ◆ Grade players according to their badminton ability
- ◆ Refuse entry to any individual
- ◆ Terminate a membership if considered in breach of the rules
- ◆ Set the amount of membership/subscription fees payable at the Annual General Meeting
- ◆ Membership fees to be paid on joining the club and subscription fees paid at weekly session

Committee and Meetings

The committee shall consist of the following roles:

- ◆ Chairperson
- ◆ Secretary
- ◆ Treasurer
- ◆ Committee members
- ◆ Child Welfare Officer

The committee shall be elected annually at the general meeting, normally from coaches and parents of members. The committee may fill any vacant position.

The committee to meet at least 4 times annually, a quorum shall be 4 committee members.

Officers will be elected annually at the Annual General Meeting. All officers will retire each year but will be eligible for re-appointment.

Finances

The financial year will run from 1st September to 31st August

The committee shall determine the budget allocation for the following year and approving the year's accounts. To ensure there is ONE year's worth of running costs in reserved in the account.

The monies of MJBC shall be held in a current /interest bearing account at a recognised bank/building society in the name of MJBC

The treasurer shall be responsible for the finances and operation of the MJBC account.

Two from the three undersigned shall sign any cheques drawn on the account

Dissolution

If MJBC should dissolve, after satisfaction of all debts and liabilities, any assets whatsoever remaining shall be delivered to Nottinghamshire Junior Badminton Association or its successor body to be used for the benefit of junior badminton within the county of Nottinghamshire

Rules for MJBC members

The committee shall have the power to set and alter rules provided they are consistent with this constitution of which they form part. They shall be approved at the Annual General Meeting

Any disputes can be resolved with the assistance of BA of E and or NJBA and or NBA

Disciplinary Process

- 羽毛球 The Management Committee will be responsible for disciplinary hearings of members who infringe the club rules/regulations/constitution. The Management Committee will be responsible for taking any action of suspension or discipline following such hearings which will be conducted in accordance with the Badminton England Disciplinary Regulations.
